Nifty weekly contract has the highest open interest at 24000 CE and 23000 PE while monthly contracts have the highest open interest at 24000 CE and 23000 PE. The highest OI addition was seen at 23800 CE and 23000 PE in weekly and at 24000 CE and 23000 PE in monthly contracts. FII's increased their future index long holdings by 2.57%, decreased future index shorts by 0.52% and in index options, 13.37% increase in Call longs, 7.39% increase in Call short, 5.44% increase in Put longs and 46.47% increase in Put shorts.
