## **Market Updates**

The markets are expected to open marginally higher today as trends in GIFT NIFTY indicate a positive start for the broader index after NIFTY closed 86 points higher at 23,249 on Thursday.

#### **Aarti Industries**

The company acquired 49% in Clean Max Indus for a 16.50 MW wind-solar hybrid project under the captive model to cut power costs.

#### **Affle**

The company has been granted a new patent in India for a system that utilizes advertisement fraud data to blacklist or whitelist entities, enhancing its intellectual property portfolio.

#### **Bajaj Healthcare**

The company received approval from the DCGI to manufacture both the API and drug formulation of Pimavanserin, a 34 mg capsule used for treating Parkinson's disease psychosis.

#### **Equinox India**

The company provided a corporate guarantee of up to ₹950 crore for NCDs issued by subsidiary Lucina Land Development.

#### **IRCON**

The company secured a ₹164.11 crore share in a ₹631.20 crore EPC contract for road construction in Manipur under a JV with AMRIL.

#### **JSW Steel**

The company's JV with JFE Steel completed 100% acquisition of thyssenkrupp Electrical Steel India for ₹4,158.6 crore, securing GOES technology.

### **KPI Green Energy**
