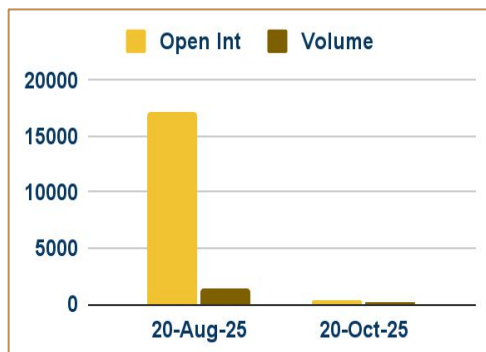

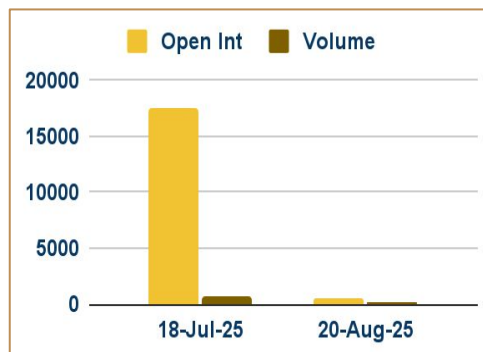

OI & Volume Chart

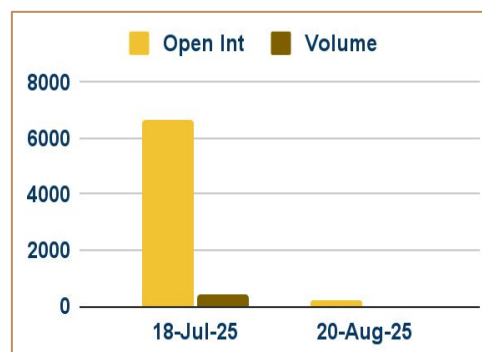

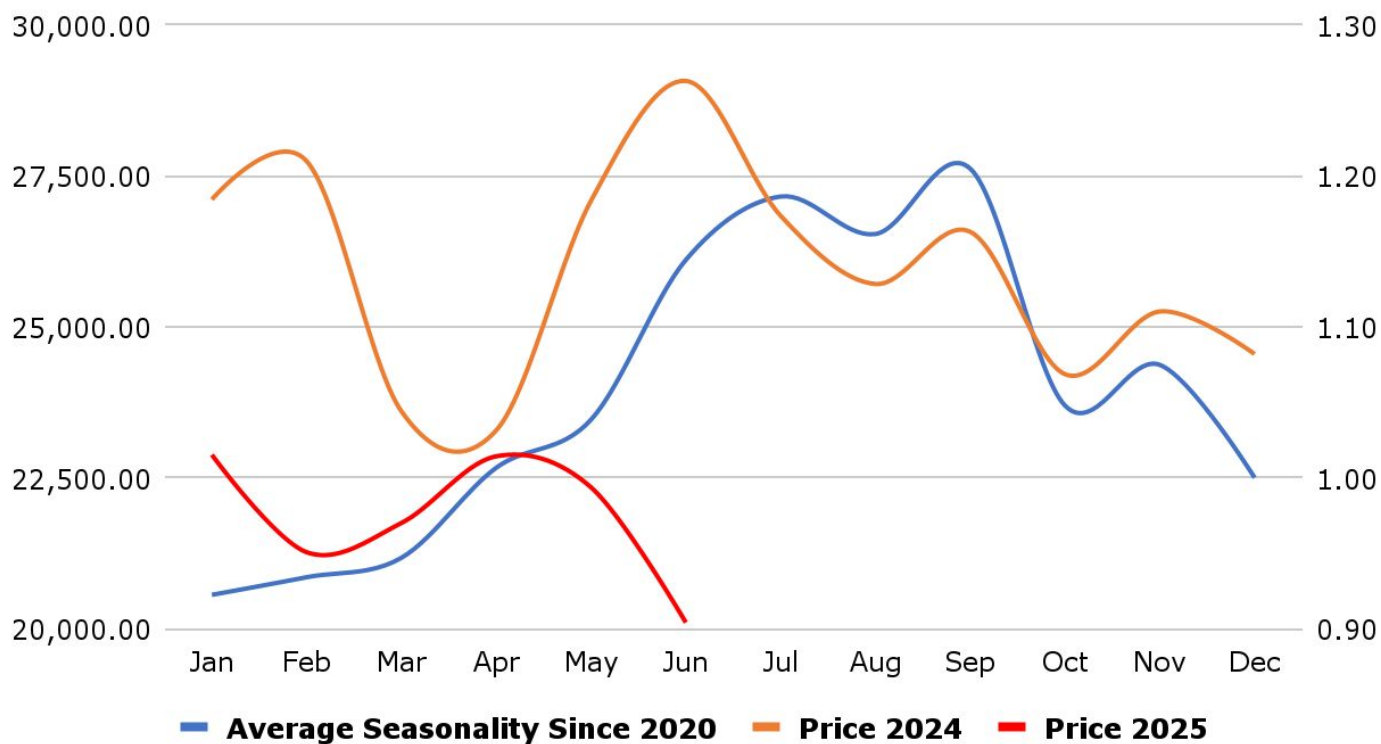
Observations

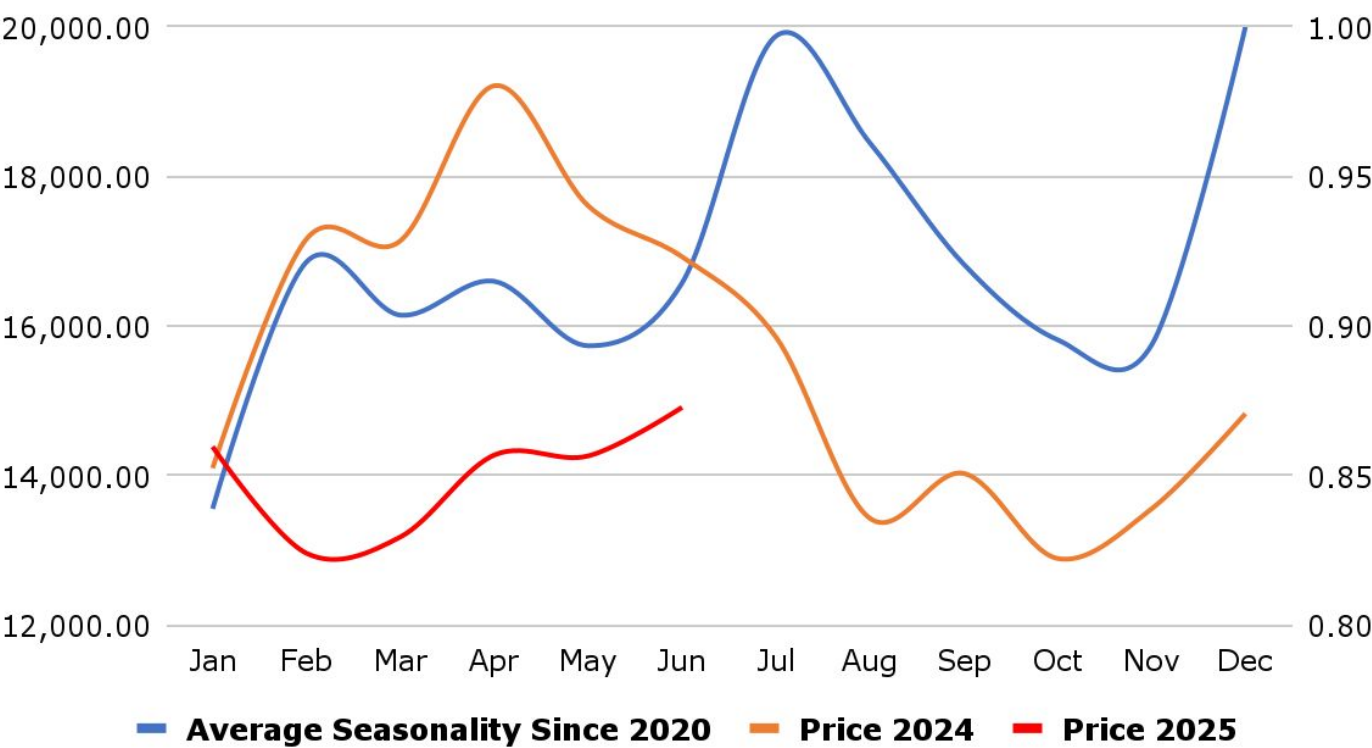
NCDEX Jeera Seasonality
