




- Equity benchmarks closed lower on Monday.

INDEX FUT SUPPORT/RESISTANCE LEVELS





NIFTY FUT TECHNICAL OUTLOOK

- Nifty is expected to open on a flattish note and likely to witness range bound move during the day.
- On technical grounds, Nifty has an immediate support at 25890. If Nifty closes below that, further downside can be expected towards 25800-25740 mark.
- On the flip side 26070-26140 will act as strong resistance levels.

BANK NIFTY FUT TECHNICAL OUTLOOK

- Bank Nifty is expected to open on a flattish note and likely to witness range bound move during the day.
- Bank Nifty's next immediate support is around 58800 levels on the downside and on a decisive close below expect a fall to 58680-58540.
- There is an immediate resistance at 59100-59250 levels.
