The markets are expected to open marginally higher today as trends in GIFT NIFTY indicate a positive start for the broader index after NIFTY closed 10 points higher at 23,668 on Tuesday.

Bansal Wire Industries

The company signed an MoU with the Ministry of Steel to avail benefits under PLI Scheme 1.1 for Specialty Steel.

Borosil

The company approved incorporating a wholly owned subsidiary, Stylenest India, for marketing and distributing household and kitchenware products with ₹50 lakh investment.

Coal India

The company received incorporation approval for its JV 'Coal Gas India' with GAIL to develop the coal-to-SNG business.

Concord Biotech

The company commenced commercial production of injectables at its new manufacturing facility, Unit-4, in Valthera.

Engineers India

The company secured two contracts in the Middle East for PMC and Engineering & Project Management Services worth approx. ₹730 crores.

HCLTech

The company launched HCLTech Insight, an AI-powered solution using Google Cloud tools to enhance manufacturing analytics, defect detection, and operational efficiency.
