

### **Market Review**

**US:** US stocks rose modestly on Tuesday, with the S&P 500 and Dow Jones Industrial average notching record closes. Investors digested China's launch of aggressive stimulus and a notable dip in US consumer sentiment.

**Asia:** Indices in the Asia-Pacific region rose in early trade on Wednesday after Chinese authorities eased liquidity to boost economic growth.

India: Benchmark equity indices closed flat after the NSE Nifty 50 briefly crossed the significant 26,000 mark in the final hour of trading. Market is expected to open on a flattish note and likely to witness range bound move during the day.

**Global economy:** Australian consumer price index inflation eased as expected in August, hitting a three-year low following government programs aimed at curbing high energy costs, while declines in core inflation were much less pronounced. CPI inflation grew 2.7% year-on-year, data from the Australian Bureau of Statistics showed on Wednesday. The reading was in line with expectations and eased sharply from the 3.5% seen last month. Core inflation- which excludes volatile items such as fuel, fresh food and holiday spending, fell to 3% in August from 3.7% in the prior month.

Japanese manufacturing activity shrank more than expected in September as major automakers continued to grapple with production disruptions, while services activity picked up on strong consumer demand. The au Jibun Bank manufacturing purchasing managers index read 49.6 in early-September, less than expectations of 49.9 and worse than the 49.8 seen in the prior month.

**Commodities:** Oil prices steadied on Wednesday after rising in the previous session on fading excitement for the economic stimulus in China, the world's biggest crude importer, though an industry report showing falling U.S. crude and fuel inventories supported the market.

Gold prices remained steady near record highs on Wednesday, supported by a weaker dollar and heightened Middle East conflict

**Currency:** The Australian and New Zealand dollars reached multi-month highs, driven by China's aggressive stimulus measures. The yuan also hit its strongest level in over a year. Despite a slight dip in the Aussie after domestic inflation data, global markets were buoyed by China's support measures, impacting currencies linked to its economy.

# Mazagon Dock Shipbuilders Ltd. Commences Production Activity for the First Multipurpose Cargo Vessel

Mazagon Dock Shipbuilders Ltd. commenced the production activity for the first Multipurpose Cargo Vessel for Navi Merchants, Denmark, on September 24, 2024. MDL has signed a contract with Navi Merchants, Denmark to design, build, and deliver a total of 6 + (4 optional) vessels, each with a capacity of 7500 DWT. # Procter & Gamble Bangladesh terminates distribution agreement with Gillette India

Shaving products maker Gillette India on Tuesday informed that Procter & Gamble Bangladesh has terminated the distribution agreement with the company. Gillette India has received a letter from its distributor, Procter & Gamble Bangladesh, notifying the termination of the distribution agreement with the company, which will be effective December 31, 2024. As a consequence of this termination, the company will have an impact of proportionate drop in net sales under this agreement, according to a regulatory filing from Gillette India. (BS)

### WACR climbs to 6.69% amid banking system liquidity deficit

The weighted average call rate, which indicates banks' overnight cost of borrowing, closed at 6.69% on Thursday, 19 basis point higher than the Reserve Bank of India's current repo rate of 6.50%, due to deficit liquidity conditions in the banking system, money market dealers said. The WACR, which is the operating target of the RBI's monetary policy, was at 6.68% the previous day. The WACR rises when liquidity conditions in the banking system are in a deficit mode.(ET)

# Elliott to call special Southwest shareholder meeting for leadership overhaul

Activist investor Elliott Investment Management on Tuesday escalated its boardroom battle with Southwest Airlines , saying it plans to call a special shareholder meeting as soon as next week to overhaul the airline's leadership. The hedge fund has launched a campaign to oust CEO Bob Jordan and other top executives, blaming them for the company's underperformance. It wants the U.S. carrier to change the way it runs its business and has laid out plans to replace two-thirds of the board's 15 directors. (inv)


