Market Review

US: US markets fell Thursday (July 11), snapping a multiday run of records as investors pivoted towards underbought equities and away from artificial intelligence names. This shift came as the yield on US Treasury bonds fell further amid rising expectations of interest rate cuts following better US inflation data.

Asia: Most Asian markets were trading lower on Friday amid positive inflation reports from the US, as the Japanese yen strengthened against the dollar on speculation of intervention. India: Indian benchmark indices ended marginally lower in the volatile session on July 11, ahead of US inflation data due later in the day. At close, the Sensex was down 27.43 points or 0.03 percent at 79,897.34, and the Nifty was down 8.50 points or 0.03 percent at 24,316. Market is expected to open on a positive note and likely to witness range bound move during the day.

Global economy:

Britain's economy grew more quickly than expected in May, providing some momentum for the new government of Prime Minister Keir Starmer but adding to doubts about whether the Bank of England will cut interest rates next month. Economic output increased by 0.4% in May, after zero growth in April. A Reuters poll of economists had pointed to a 0.2% monthly increase.

U.S. inflation slowed marginally in June on an annual basis, and a gauge of core prices closely watched by the Federal Reserve also slowed, pointing to a cooling of pricing pressures. The U.S. consumer price index rose 3.0% in June on an annualized basis. Economists had expected the number to fall to 3.1% from 3.3% in May.

Natural disasters in China resulted in 93.16 billion yuan (\$12.83 billion) worth of direct economic loss in the first half of this year, as the country suffered flooding, drought and extreme temperature. The Emergency Management Ministry said disasters affected 32.38 million people over January-June and led to the disappearance or death of 322 people.

Commodities: Oil prices rose in Asian trade on Friday amid optimism over U.S. interest rate cuts and improved summer demand, but were still set for weekly losses on some profittaking.

Gold prices eased on Friday but headed for a third straight weekly rise, after cooler-than-expected U.S. inflation data sparked hopes that the Federal Reserve will likely start cutting interest rates in September.

Currency: The yen was volatile Friday as the Bank of Japan conducted so-called rate checks with traders, reinforcing perceptions that authorities intervened in the market on Thursday to prop up the currency.

Aditya Birla Fashion Acquires 51% Stake In Tarun Tahiliani Brand Goodview Fashion

Aditya Birla Fashion and Retail Ltd. announced on Thursday that it has raised its stake in Tarun Tahiliani brand's parent company Goodview Fashion Pvt. from 33.5% currently to 51% for Rs 127 crore. The company achieved this through a secondary acquisition of an additional 17.5% equity stake from Goodview Fashion's existing shareholders. Following the transaction, Goodview Fashion, which manufactures and sells ethnic couture under the Tarun Tahiliani brand, has become a subsidiary of the company effective from July 11, 2024. (BQ)

Oriental Rail's Subsidiary Wins Rs 432 Crore Indian Railways Contract

Oriental Foundry Pvt., the wholly-owned subsidiary of Oriental Rail Infrastructure Ltd., announced that it has secured an order worth Rs 432 crore from the Indian Railways. The order, which involves the manufacturing and supply of 1,200 BVCM-C wagons, is to be executed by Mar'26. This follows the Indian Railways' announcement on July 9 that it will manufacture 10,000 non-air-conditioned coaches over the next two fiscals to enhance facilities for common passengers. This initiative will increase the number of non-AC coaches by 22%. (BQ)

Economy

India's vegetable oil imports up 18% in June to 15.5 lakh tonnes

Import of vegetable oils, comprising edible and non-edible oils, rose 18 per cent in June to 15.5 lakh tonnes on higher imports of crude palm oil and crude sunflower oil, according to trade data. Solvent Extractors' Association of India (SEA) data showed that import of vegetable oils during June 2024 stood at 15,50,659 tonnes compared to 13,14,476 tonnes in the yearago period. (ET)

India June palm oil imports rise about 3% MoM

India's palm oil imports in June rose to reach the highest level in six months on robust demand from refiners for upcoming festivals, while sunflower oil imports surged to a record level, a leading trade body said on Thursday. (ET)

International

Air Incheon to consider widebody freighter orders after Asiana cargo purchase

Air Incheon, set to become South Korea's second-biggest freight carrier once a deal to buy Asiana Airlines' cargo unit is finalised, will consider both Boeing (NYSE:BA) and Airbus freighters to refresh the widebody fleet, its CEO said. (Inv)
