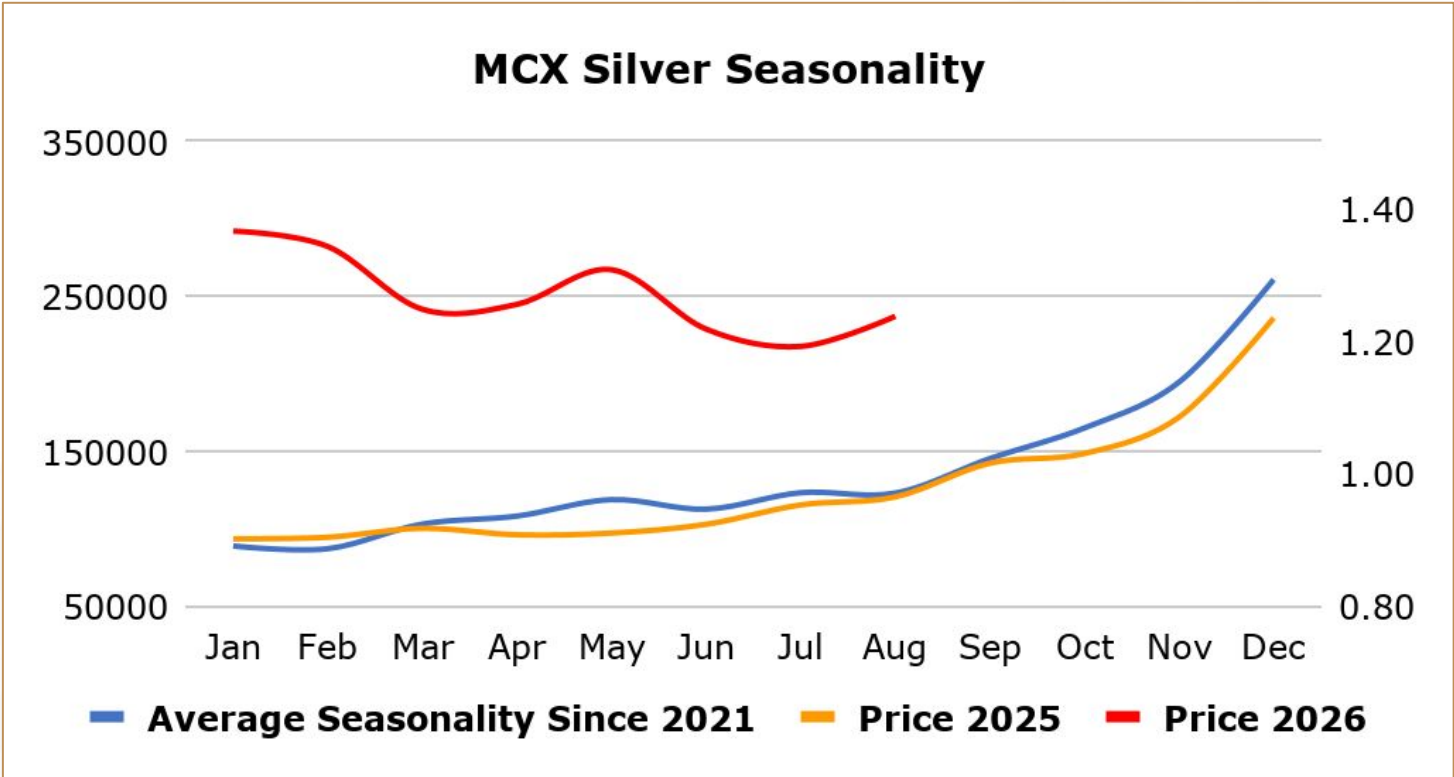
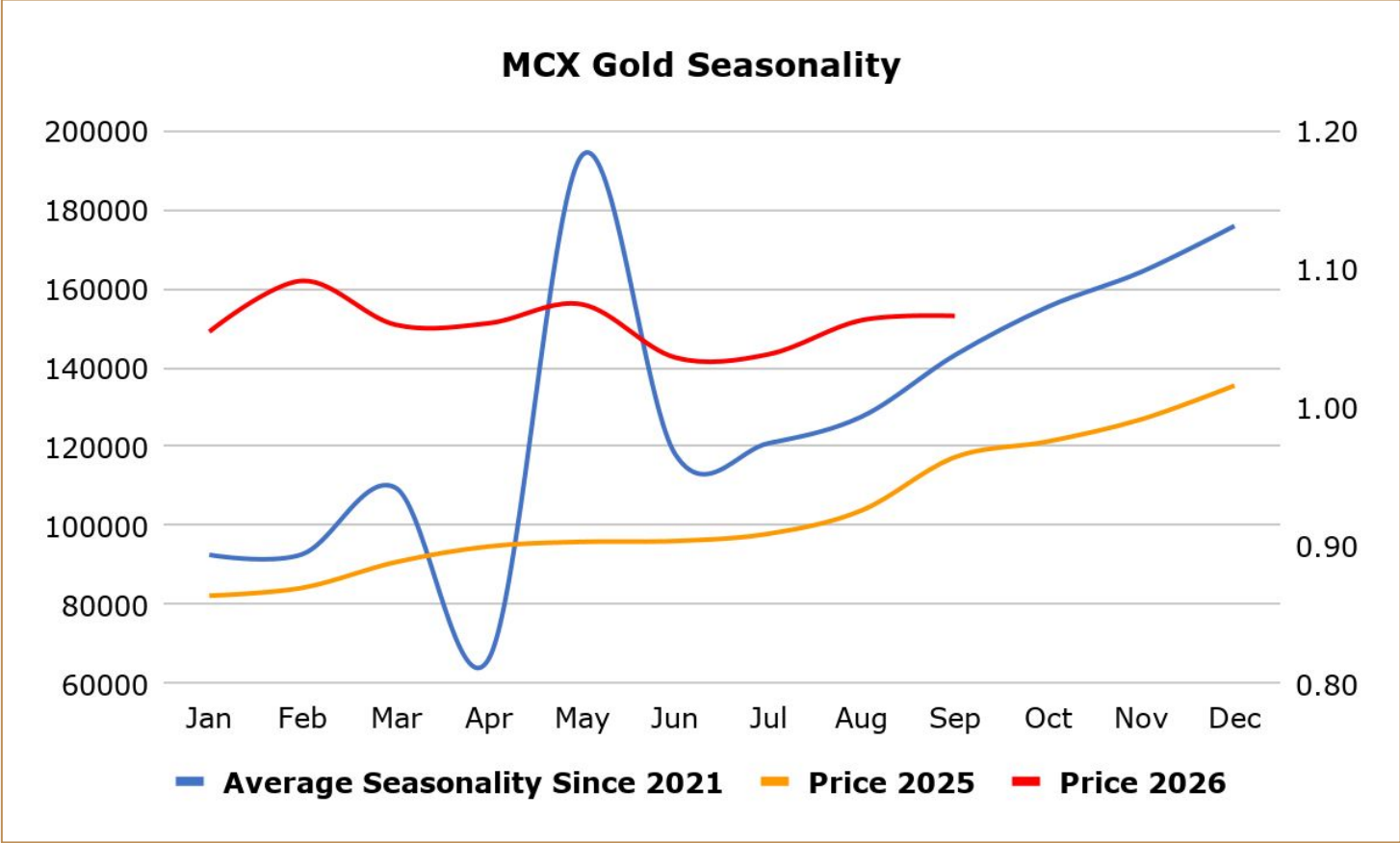
Gold rose supported by a weaker US dollar as investors assessed renewed inflation risks from escalating Middle East tensions and awaited key US inflation data for clues on the Federal Reserve's policy outlook. The dollar slipped to a four-month low, with investors looking ahead to producer-price data due Thursday and the consumer price index on Friday. The releases could provide the final major input into expectations for the Fed's policy decision on September 16. Meanwhile, oil prices surged to their highest level in more than three months as US-Iran tensions intensified. Iran's Revolutionary Guard said it had fired ballistic missiles at a US-used military base in Jordan and attacked 10 ships on Wednesday, after Washington said it had destroyed five Iranian oil tankers. Markets are now pricing in around a 60% chance of a Fed rate hike at next week's policy meeting.

Gold demand improves in India, holds firm in China on investment interest - Gold demand in India improved as a drop in prices spurred some buying interest, while investment flows continued to support consumption in top consumer China despite slow jewellery sales. Indian Prime Minister Narendra Modi reiterated that people should refrain from buying gold unless necessary, making a similar appeal in May, after which the country raised import duties on gold and silver to 15% from an earlier 6%. Dealers quoted a discount of up to \$54 an ounce over official domestic prices, inclusive of 15% import and 3% sales levies, a drop from last week's discount of up to \$135. In China, bullion traded at premiums of \$3.5-\$9 an ounce to the global benchmark price, compared with discounts of \$2-\$5 last week. In Singapore, gold was sold between a \$1 discount and a premium of \$2 this week, while in Hong Kong it traded at premiums of \$0.5 to \$1.5. Meanwhile, in Japan, gold was sold between a \$0.25 discount and a \$0.5 premium.

China's central bank continues to step up gold buying in August - China's central bank stepped up its gold purchases for a sixth straight month in August, adding the most bullion to its reserves since October 2023 and extending its buying streak to a 22nd consecutive month, official data showed. The People's Bank of China's gold holdings rose to 76.73 million fine troy ounces at the end of August from 76.08 million ounces a month earlier. The 650,000-ounce addition, equivalent to about 20.2 metric tons, was slightly larger than the 640,000 ounces added in July and the biggest monthly increase since October 2023, when holdings rose by 740,000 ounces. The pace of purchases has been increasing since March, when the central bank added 160,000 ounces. It added 480,000 ounces in June. The value of China's gold reserves jumped to \$350.08 billion at the end of August from \$306.35 billion a month earlier, the data showed, reflecting both fresh purchases and a sharp rise in gold prices.

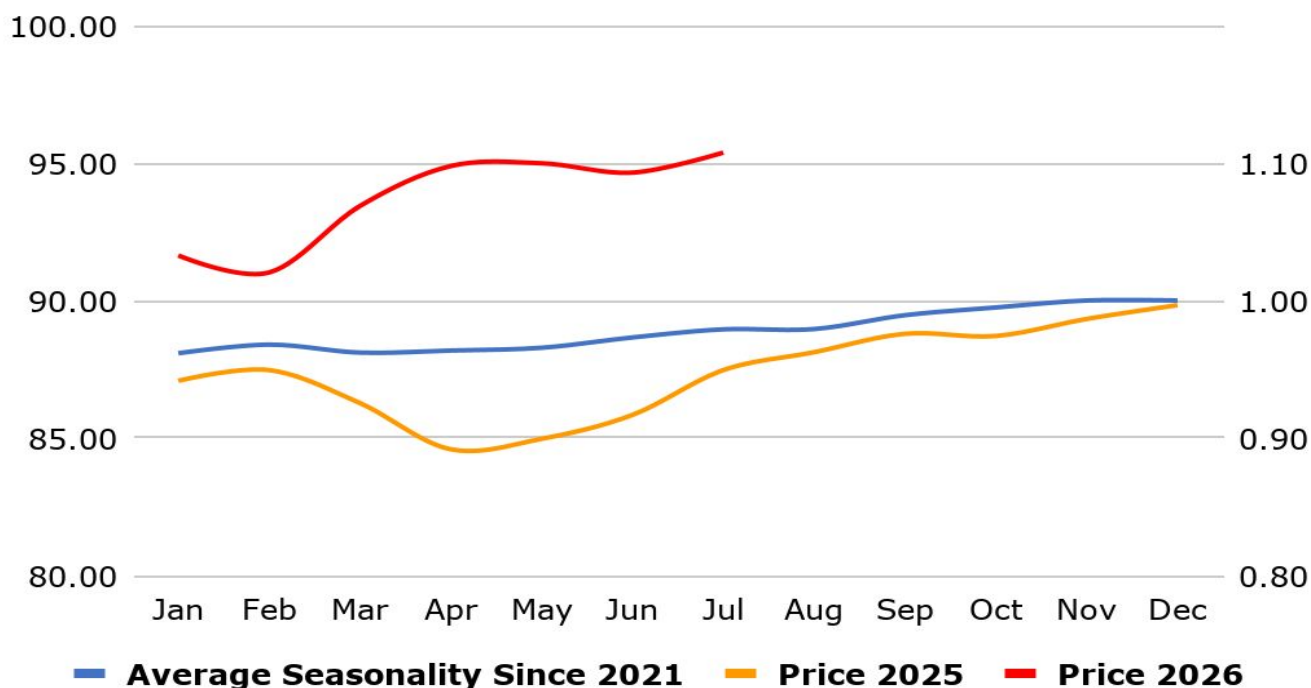
Gold demand steady in second quarter as central bank buying offsets ETF outflows - Global gold demand was steady year-on-year at 1,268.9 metric tons in the second quarter of 2026 as central banks sped up purchases, offsetting a slump in investment, the World Gold Council said. Outflows from gold-backed exchange-traded funds totalled 45 tons in the second quarter, when bullion posted its sharpest quarterly decline since 2013, falling 14%. Led by Poland and China, central bank net gold demand picked up significantly in the second quarter, reaching 289 tons – a fivefold increase from the first quarter's revised estimate of 57 tons, the WGC said. It estimated January to March demand from central banks at 244 tons three months ago, but then Turkey, Russia and Azerbaijan's Sofaz reported detailed data about their sales for the period.

Swiss gold exports drop 2% in July as deliveries to China fall - Swiss gold exports fell 2% in July from the previous month as lower shipments to China and Hong Kong offset higher deliveries to Britain and India, Swiss customs data showed. Supplies to China, a key bullion consumer, fell 22% month on month to 21.8 metric tons in July, while deliveries to Hong Kong slumped to 1.4 tons from 8.1 tons in June, the data showed. China's central bank purchased 19.9 metric tons of gold in July, its biggest monthly addition since October 2023, supporting overall demand sentiment in the country. Bullion has traded at a small premium to London prices in China for six straight weeks. GOL/AS Deliveries to the UK from Switzerland, the world's biggest bullion refining and transit hub, jumped 44% to 39.5 metric tons last month. Britain is home to the world's largest over-the-counter gold trading hub.
