


Market Review

US: US stocks slipped on Tuesday, as investors become cautious ahead of the Federal Reserve's interest rate decision following strong retail sales data.

Asia: Asian shares turned higher, shrugging off Wall Street's modest declines as traders braced for the Federal Reserve's final policy decision of the year.

India: Indian benchmark equity indices witnessed heavy selling pressure in trade on Tuesday, extending losses to the second straight session Market is expected to open on a negative note and likely to witness range bound move during the day.

Global economy: Japan's trade balance unexpectedly improved in November on support from stronger-than-expected exports, as demand in the U.S. and China improved and as a softer yen also helped. Trade balance was a deficit of 117.6 billion yen (\$770 million), government data showed on Wednesday. The reading was stronger than expectations for a deficit of 688.9 billion yen, and also improved from October's deficit of 462.1 billion yen. The improved trade balance was driven chiefly by stronger-than-expected exports, which rose 3.8% year-on-year in November against expectations of 2.8%. Growth also picked up from the 3.1% seen in the prior month..

US industrial production saw a slight decline according to recent data, marking a continued slowdown in the manufacturing sector. The actual figure came in at a decrease of 0.1%, providing a less dismal picture than the anticipated decline of 0.3%. This data, which measures the inflation-adjusted value of output from manufacturers, mines, and utilities, is a key indicator of the health of the industrial sector. A higher reading is typically bullish for the US dollar, while a lower reading is bearish.

Commodities: Oil prices traded in a narrow range early on Wednesday as investors remained cautious ahead of an expected interest rate cut by the U.S. Federal Reserve.

Gold prices firmed on Wednesday as investors held back from taking big positions ahead of the Federal Reserve's upcoming monetary policy decision.

Currency: The U.S. dollar held steady against the yen and other major rivals on Wednesday as investors waited to see whether the Federal Reserve will deliver a hawkish cut before the Bank of Japan and other central banks meet this week.

RBI Lifts Ban on ECL Finance, Edelweiss Asset Reconstruction with Immediate Effect

The RBI lifted business restrictions on ECL Finance Ltd. and Edelweiss Asset Reconstruction Co., as the central bank was satisfied with remedial measures put in place by the companies. The move comes after the central bank had imposed business restrictions on both companies belonging to the Edelweiss Group in May. (NDTV)

Ambuja Cements Approves Merger of Sanghi Industries, Penna Cement with Itself

Ambuja Cements Ltd.'s board approved the merger of its recently acquired entities Sanghi Industries Ltd. and Penna Cement Industries Ltd. with itself through separate schemes of arrangement. The Adani Group cement-maker will issue 12 equity shares of fv of Rs 2 each for every 100 equity shares of Sanghi Industries of fv Rs 10. (NDTV)

Exide Industries infuses Rs 100 cr in Exide Energy Solutions

Exide Industries announced that it has invested around Rs 100 cr in its wholly owned subsidiary, EESL by way of subscription in the equity share capital on rights basis. With this, the total investment, as on date, made by the company in EESL now stands at Rs 3152.24 cr, including investment made in erstwhile merged subsidiary Exide Energy Private Limited. (FE)

US to update its MTCR export control policies for India

The Biden administration is finalizing a national security memorandum to update US export control policies, easing space sector collaboration with India. This move aims to reduce barriers for US companies partnering with Indian counterparts, exploration and fostering joint space technological potential advancements, including Indian astronaut participation in future US missions. Indian banking liquidity deficit hits highest in six months

India's banking system faced its highest liquidity deficit in nearly six months due to advance tax payments and likely central bank intervention to stabilize the rupee. The deficit reached ₹1.5 tn (\$17.7 bn), pushing up borrowing costs. (ET)

Eli Lilly Alzheimer's drug donanemab approved in China

China's food and drug regulator had approved its Kisunla treatment for early symptomatic Alzheimer's disease- the fourth major market to approve the treatment. The treatment was approved by the National Medical Products Administration in China. (Inv)
