Market Updates

The markets are expected to open marginally higher today as trends in GIFT Nifty indicate a positive start for the broader index after Nifty closed 81 points lower at 25,198 on Wednesday.

Allied Blenders and Distillers:

The company has acquired a majority stake in a new entity, in collaboration with Oh Five Oh Talent, with the acquisition costing ₹700 crore; the new entity will be part of the alcoholic beverages industry.

Borosil Renewables:

The company has acquired a 49% stake in Clean Max Prithvi.

Century Textiles & Industries:

The company's unit will purchase Hindalco land in Kalwa, Thane, with the company providing a ₹400 crore corporate guarantee for the land to Hindalco.

Foce India:

The company has approved raising ₹490 million through a rights issue of shares.

Godrej Properties:

The company has approved the key information document for the issuance of 6,460 NCDs worth ₹646 million.

Interarch Building Products:

The company invests over ₹95 crores in a 5" PEB manufacturing plant, adding 60,000 MT/annum in 2 phases and boosting total capacity to 200,000 MT/annum.

Linde India:

The company has entered into a plant sale agreement with Tata Steel to acquire their industrial gas supply assets, including two 1,800 TPD air separation units (ASUs) at the Kalinganagar Phase 2 expansion project.

Lupin:

The company has launched Mirabegron extended-release tablets in the United States, where the product's sales are valued at \$1.6 billion.

Minda Corporation:

The company has partnered with China's Sanco Connecting Technology to advance its EV product portfolio, including charging systems and distribution units.

Parin Furniture:

The company received a contract from the Ministry of Civil Aviation, Airports Authority of India, for supplying airport furniture to Vadodara Airport with a total order value of ₹77 lakhs.

RITES:

The company signed an MoU with NBCC to jointly pursue consultancy, fee-based projects, and EPC contracts across urban energy, water management, transport, and infrastructure, handling project management and consultancy, while NBCC focuses on implementation and construction.

Samvardhana Motherson:

The company plans to complete fundraising by the end of September, raising up to \$715 million via a share sale to repay debt and fund expansion.

Suzlon Energy:

The company executed a conveyance deed with OE Business Park for the sale of the One Earth property, receiving ₹4.4 billion from the sale.
