


#### **Market Review**

**US:** US stock indexes finished higher after a choppy trading session on Wednesday, falling early and then rebounding as investors made last-minute bets to position themselves ahead of Trump's sweeping tariff announcements.

**Asia:** Asian markets plunged on Thursday, after US President Donald Trump imposed hefty reciprocal tariffs on over 180 countries and territories - several of which are in the region.

India: Benchmark Indian equity indices settled in positive territory on Wednesday, ahead of the reciprocal announcement by US President Donald Trump. Market is expected to open on a gap down and likely to witness sideways move during the day.

**Global economy:** China's services sector grew more than expected in March, private purchasing managers index data showed on Thursday, as local demand and business activity benefited from Beijing's stimulus measures. Local demand improved following Beijing's measures to boost private spending and support local businesses, which were rolled out since late-2024.

Australia's trade balance sank to a more than four-year low in February, falling well short of expectations, as exports tumbled while imports jumped on stronger demand for consumer goods. Trade balance shrunk to a surplus of A\$2.97 billion in February, much lower than expectations of an A\$5.38 billion surplus.

**Commodities:** Oil prices dropped \$2 on Thursday after U.S. President Donald Trump announced reciprocal tariffs on trading partners, stoking concerns that a global trade war may dampen demand for crude.

Gold hit a record high on Thursday, as nervous investors rushed towards safe-haven assets after U.S. President Donald Trump announced more aggressive-than-anticipated tariffs against major trading partners, widening the global trade war.

**Currency:** The U.S. dollar fell on Thursday after President Trump announced new tariffs targeting around 60 countries, escalating trade tensions and impacting global markets. Investors moved towards safe havens like the yen and Swiss franc, while the euro showed resilience.

## Bharat Electronics signed a contract of Rs 593cr with Indian Air Force

BEL has signed a contract with Indian Air Force valued at Rs 593.22 cr (excluding taxes) for providing maintenance services for the Akash Missile System, which was supplied by the company. The company also concluded negotiations with customers for acquisition of orders worth Rs 5,000 cr. (MC)

# Reliance lays foundation for first of 500 CBG plants in Andhra Pradesh

Reliance Industries has started its Rs 65,000 cr investment in compressed bio-gas (CBG) hubs in Andhra Pradesh. The foundation stone for the first integrated CBG plant, set up by Reliance New Energy, was laid in Kanigiri. Spanning 475 acres, the plant involves an investment of Rs 139 crore and will have a production capacity of 100 tonnes. This facility is part of Reliance's plan to establish 500 CBG plants across the state (BS)

### Mazagon Dock Shipbuilders Commences Keel Laying for Navi Merchants

Mazagon Dock has marked a significant milestone with the keel laying ceremony for the first of six Multi-Purpose Vessels (MPVs) for Navi Merchants Denmark. The vessels, each priced at ~ \$14M, are designed to be 116.2 meters long with a dead weight of 7500 tons and a speed of at least 11 knots. This project, under the rules of the Det Norske Veritas classification society, is scheduled for delivery in April 2026 and underscores MDL's capabilities in shipbuilding, potentially enhancing its market position and stakeholder confidence. #### Impact of US Tariffs on Indian Exports: Mixed Outlook

The 26% tariff imposed by the U.S. on Indian imports is set to hit sectors like textiles, engineering goods, electronics, and gems & jewellery, squeezing exporter margins and increasing economic uncertainty. However, India's agricultural exports may remain resilient, as competitors like China (34%), Vietnam (46%), and Thailand (36%) face even higher tariffs. This relative advantage could help India sustain or expand its farm exports, particularly in seafood and rice. (ET)

## Boeing awarded \$133.5M contract for P-8A training systems for South Korea

The U.S Department of Defense has awarded a \$133.5M contract to The Boeing Co based in St. Louis, Missouri. The deal is a modification to a previous order and involves expanding the scope of the P-8A training systems project. Under this contract, Boeing is set to procure phase two software development, integration, and device installation for the South Korean government. (Inv)
