US: Wall Street seesawed between marginal gains and losses on Thursday, as investors grappled with President Donald Trump's latest trade gambit that sent auto stocks into a tailspin, all while digesting a myriad of economic data.

26-Mar

Asia: Asian shares fell Friday, mirroring US equities, as concerns about the upcoming 'reciprocal tariffs' and a widening trade war overshadowed data showing that the US economy grew faster than estimated.

India: Indian benchmark indices ended nearly half a percent higher each on March derivatives series expiry day. Bulls dominated the trading session, erasing early weakness over US automotive tariffs, with Nifty 50 index ending near 23,600 on across-the-board buying, barring auto and pharma names. Market is expected to open on a flattish note and likely to witness range bound move during the day.

Global Economy: U.S. corporate profits surged to a record high in the Q4 amid strong demand and pricing power, but an uncertain economic outlook due to tariffs is creating a challenging environment for businesses that economists say could force companies to lay off workers to protect margins. The report from the Commerce Department also showed the economy grew at a slightly more solid clip last quarter than previously estimated, driven by preemptive buying of big-ticket items like motor vehicles ahead of import duties.

Weekly Natural Gas Storage report from Energy Information Administration, showing a match with the forecasted change in the amount of natural gas held in underground storage. The actual number came in at 37 billion cubic feet (Bcf), in line with the predicted figures. The data suggests that the demand for natural gas has been accurately predicted by market analysts, and there was no unexpected surge or decline in demand.

Italy is concerned but not "terrified" of any new tariffs the United States could impose on wine, the country's agriculture minister said on Thursday, adding he hoped diplomatic efforts could avert damage to a key industry. Trump has threatened to impose a 200% tariff on wine, cognac and other alcohol imports from Europe, that has raised recession fears.

Commodities: Oil prices were little changed in Asian trading on Friday as investors braced for U.S. reciprocal tariffs starting next week, though they remained near a one-month high and headed for a third consecutive weekly gain amid concerns of a tightening supply.

Gold rose to a record as concerns about a widening trade war remained front of mind for investors, after President Donald Trump pushed ahead with US tariffs on all auto imports.

Currency: The dollar was headed for a steady week on Friday and a quarterly loss next week as concern about tariffs slowing U.S. growth has pushed down U.S. yields, stocks and the currency.

Asian Paints hikes capex for new Dahej manufacturing plant to ₹3,250 cr

Asian Paints Limited has approved an additional capital expenditure of ₹690 cr for its upcoming manufacturing facility in Dahej, Gujarat. This raises the total project cost to ₹3,250 cr, up from the initially estimated ₹2,560 cr. (CNBC)

HAL revises Tejas Mk1 contract to ₹6,542 cr amid delay and production hurdles

HAL has amended its contract with the IAF for the production of Light Combat Aircraft (LCA) Tejas Mk1 FOC fighter jets, increasing the deal's value from Rs 5,989.39 cr to Rs 6,542.20 cr. Meanwhile, American defence giant GE Aerospace has delivered the first of 99 F404-IN20 engines to HAL, marking a significant milestone in the Tejas programme. (ET)

Bharat Electronics Secures Orders worth Rs 1,385 Cr in Last Two Weeks

BEL has secured orders worth Rs 1,385 cr since March 12, taking the total value of accumulated orders to Rs 18,415 cr in the current financial year. The public sector undertaking's major orders include radar spares, radar upgradation, electronic voting machines, simulators, advanced land navigation system and stabiliser for tanks, fire control system for ship-based decoys and communication equipment (NDTV)

Economy

Centre to borrow Rs 8 lk cr in 1st half of FY26 through dated papers

The Centre will borrow ₹8 lakh cr via dated securities in the first half of the next fY to fund its revenue gap. This amount includes ₹10,000 cr through sovereign green bonds. The borrowing consists of various tenures, with weekly tranches and options to retain additional subscriptions to help stabilize financing without disrupting the bond market. (ET)

Govt approves procurement of 37.39 lakh tons of gram, lentils for 2025 rabi season

The government has approved the procurement of 37.39 lakh tonnes of gram, lentils, and 28.28 lakh tonnes of mustard for the 2025 rabi season, through Nafed and NCCF under the Price Support Scheme. (ET)


