

Market Review

US: US markets ended lower on Friday, with investors on edge over the Iran-Israel conflict heading into the weekend, as the U.S. considers whether to get involved.

Asia: Asia-Pacific markets declined Monday, after the US attack on three nuclear sites in Iran raised oil prices and investors fears of an escalation in the Middle East conflict.

India: Indian stock market benchmarks, the Sensex and Nifty 50, registered strong gains on Friday, despite rising tensions between Israel and Iran. Market is expected to open on a gap down note and likely to witness sideways move during the day.

Global economy: China condemned the U.S. attacks on Iran's nuclear facilities over the weekend, with Beijing calling on Israel to reach a ceasefire as soon as possible. China "strongly condemns the U.S. attacks on Iran and bombing of nuclear facilities under the safeguards of the International Atomic Energy Agency, according to comments from a Chinese foreign ministry spokesperson carried by state media. The U.S. over the weekend attacked three key nuclear facilities in Iran, with the stated goal of halting the country's nuclear ambitions.

Britain will aim to cut the electricity bills of thousands of companies under a new industrial strategy to be published on Monday, heeding calls from business to lower high energy costs that they say have damaged competitiveness and hindered growth. Under an industrial strategy for the decade 2025-2035, the government plans to cut the bills of electricity-intensive manufacturers by up to 25% from 2027, a move it said could benefit more than 7,000 businesses. The government has made boosting Britain's anaemic growth a key priority.

Commodities: Oil prices jumped on Monday to their highest since January as Washington's weekend move to join Israel in attacking Iran's nuclear facilities stoked supply worries.

Gold prices inched higher on Monday as investors turned to safe-haven assets amid growing fears of a broader Middle East conflict, with markets closely watching for Iran's response to U.S. attacks on its nuclear sites.

Currency: The U.S. dollar firmed slightly on Monday as anxious investors sought safety, although the moves were muted so far suggesting markets were waiting for Iran's response to U.S. attacks on its nuclear sites that have exacerbated tension in the Middle East.

Corporate News

Granules unit in Hyderabad, one of the largest globally for paracetamol API, under U.S. FDA scanner

Generic drugmaker Granules India's active pharmaceutical ingredients manufacturing facility in Bonthapally, Hyderabad, has been issued an observation by the U.S. FDA. The Bonthapally facility is one of the world's largest single-site paracetamol API manufacturing plants by volume. Along with paracetamol APIs, the company has established Metformin and Guaifenesin API manufacturing plants in the same facility. (TH)

Servotech Renewable Power acquired a 27% stake in Rhine Solar

Servotech Renewable Power System has acquired a 27% stake in solar PV module manufacturing company Rhine Solar. The deal is estimated at Rs 12.14 cr, and Servotech purchased 9,50,106 shares of Rhine Solar at a price of Rs 127.88 per share. Rhine Solar boasts a manufacturing capacity of 100 MW. (FE)

BEL secures fresh orders worth Rs 585 cr since June 5

Navratna Defence Public Sector Undertaking BEL has secured additional orders worth Rs 585 Cr since the last disclosure on 5th June 2025. Additionally, "major orders received include fire control and sighting system for missiles, communication equipment, jammers, spares, services etc,". (ET)

Economy

Direct tax collections rise 4.9%; advance tax up 3.9% in FY26 so far

India's gross direct tax collection for fiscal year 2025-26 increased to Rs 5.45 lakh cr as of June 19. The Income Tax Department released the latest figures. Gross collections saw a rise compared to last year. However, net collections dropped marginally. This was due to a significant surge in tax refunds. Advance tax receipts experienced overall growth. (ET)

RBI cuts small finance banks' lending requirement to priority sectors

The RBI has made a significant change. It has lowered the priority sector lending requirement for small finance banks. The mandated portion is reduced by 15% points. Now, these banks need to allocate 60% of their lending to priority sectors. Earlier, it was 75%. This decision follows a review by the RBI. (ET).

International

Tesla plans \$8 bn U.S. investment this fiscal year

Tesla plans to invest approximately \$8 bn in US infrastructure and manufacturing during the current fiscal year. The electric vehicle manufacturer revealed it has already invested around \$44 bn in capital expenditures in the US since the company's founding. Tesla noted that in the previous fiscal year alone, it made approximately \$10 bn in capital expenditures. (Invst)
