





In Gondal, a major spot market, the price ended at 7435.05 Rupees dropped by -0.16 percent.

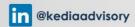
