On 5th Jan 2026, US market delivered a positive performance with S&P500 up by +43.62 pts (0.64%), Dow Jones up by +595.1 pts (1.23%) and Nasdaq up by +195.15 pts (0.77%). Gift Nifty grew by 93 pts (0.35%) indicating Indian markets will open positively. Advance-Decline ratio on NSE was 3256:1936 and on BSE was 1632:2602 which showed balance in the overall markets.

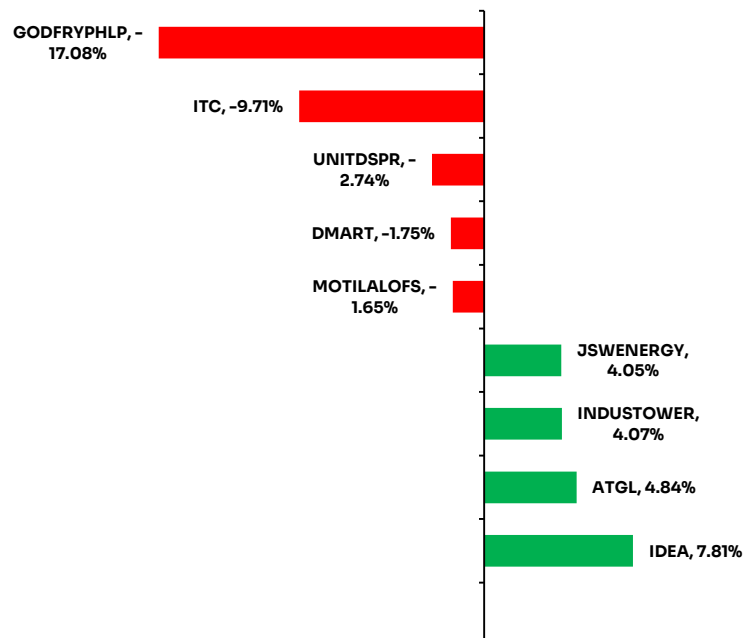

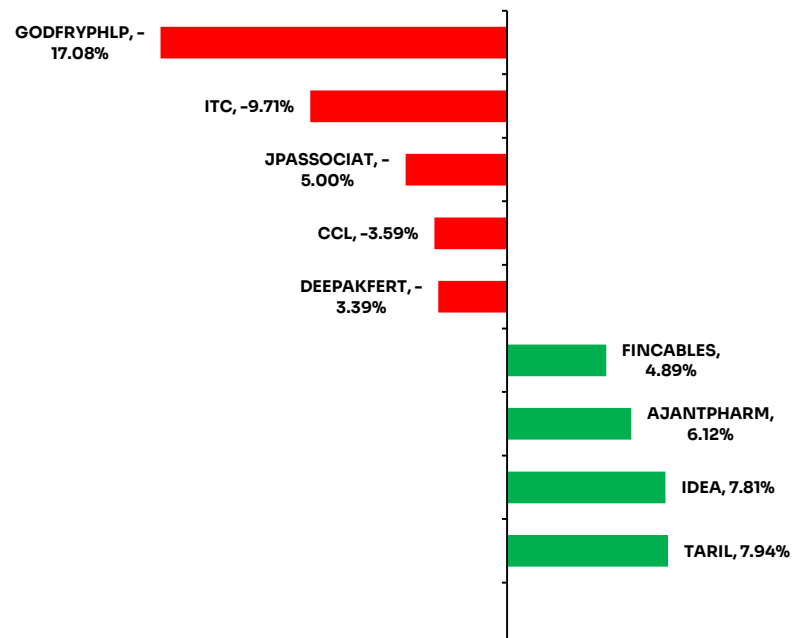
Nifty Next 50 index
