Market Updates

The markets are expected to open marginally higher today as trends in GIFT NIFTY indicate a positive start for the broader index after NIFTY closed 75 points lower at 25,157 on Wednesday.

Apollo Hospitals

The company received CCI approval for acquiring an additional 30.58% stake in its subsidiary Apollo Health and Lifestyle from IFC and IFC EAF for ₹1,254.1 crore, consolidating its ownership.

CESC

The company's subsidiary signed an MoU with Uttar Pradesh to set up solar cell and module facilities, solar power plant and R&D infrastructure with ₹3,800 crore investment.

Indo Count

The company commenced commercial production at its greenfield pillow manufacturing facility in Kernersville, North Carolina, marking its third pillow unit in the United States.

Lemon Tree Hotels

The company signed a license agreement for Lemon Tree Premier Omkareshwar, Madhya Pradesh with 85 rooms to be managed by its wholly owned subsidiary.

Lloyds Metals and Energy

The company acquired an additional 12.12% stake in Hexa Energy W2 for ₹4.16 crore, increasing its total holding to 29.23% through equity subscription.

Lupin

The company signed a licensing and supply agreement with Galenicum for injectable Semaglutide, covering regulatory approvals and commercialization across 23 countries including Europe and Canada.

Mazagon Dock Shipbuilders

The company concluded acquisition of 41.73% stake in Colombo Dockyard PLC and is in process of acquiring additional shares through a mandatory offer.

Premier Explosives

The company received a purchase order from an international client to supply rocket motors valued at ₹17.68 crore to be executed within 12 months.

Raymond Realty

The company launched 'The Address by GS, Wadala', a 5.62-acre residential redevelopment in Mumbai with estimated revenue potential of ₹5,000 crore.

Sahana System

The company received an LOA from RailTel for AI-enabled IT infrastructure implementation valued at ₹24.76 crore exclusive of GST.

Senco Gold

The company approved investment to acquire 68% stake in August Jewellery Melorra brand for ₹68 crore making it a subsidiary.

Torrent Pharmaceuticals

The company completed acquisition of 46.39% stake in JB Chemicals through purchase of ~7.45 crore equity shares and acquired promoter control.

Wipro

The company incorporated Wipro Business Services LLC, USA, a step-down subsidiary to provide end-to-end IT services including consulting, cloud, cybersecurity, data analytics and BPO, with 100% control retained by the group.
