





In Unjha, a major spot market, the price ended at 24913.7 Rupees gained by 0.33 percent.

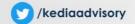
