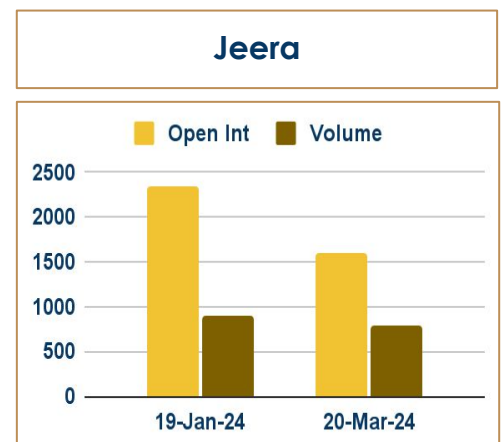
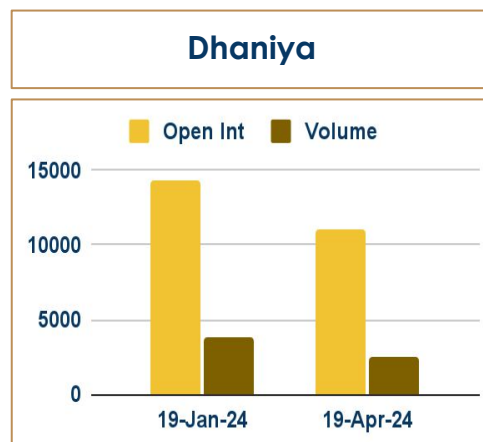
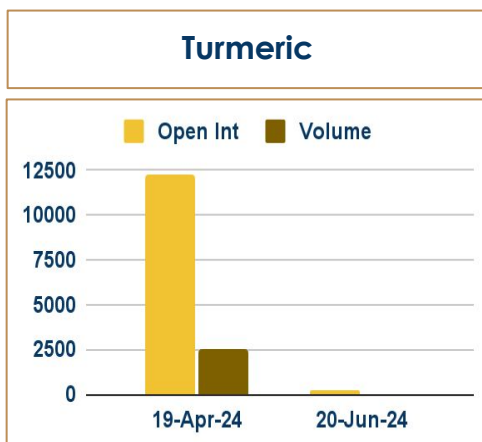

Turmeric prices drop due to slower buying activities and release of stocks.

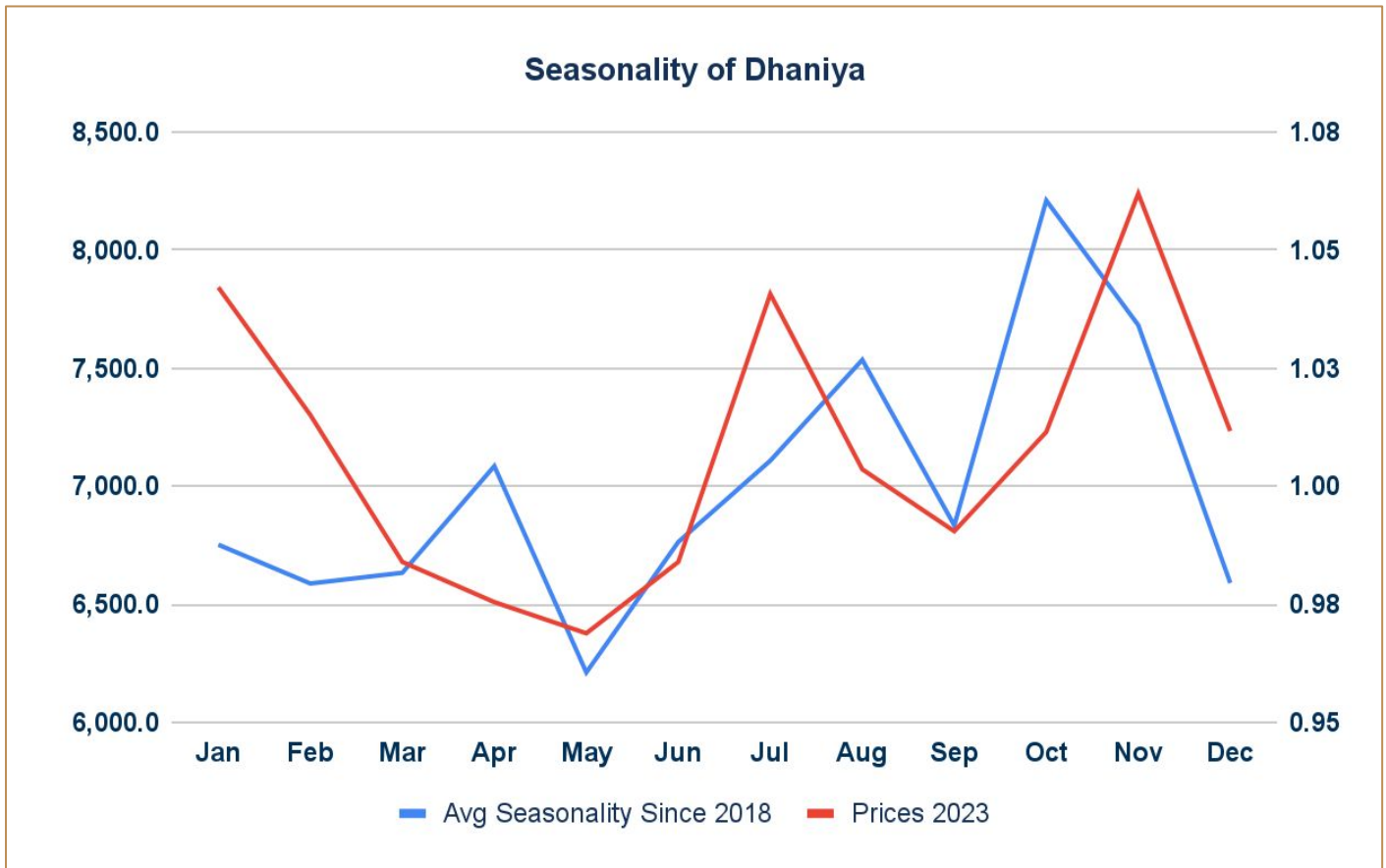
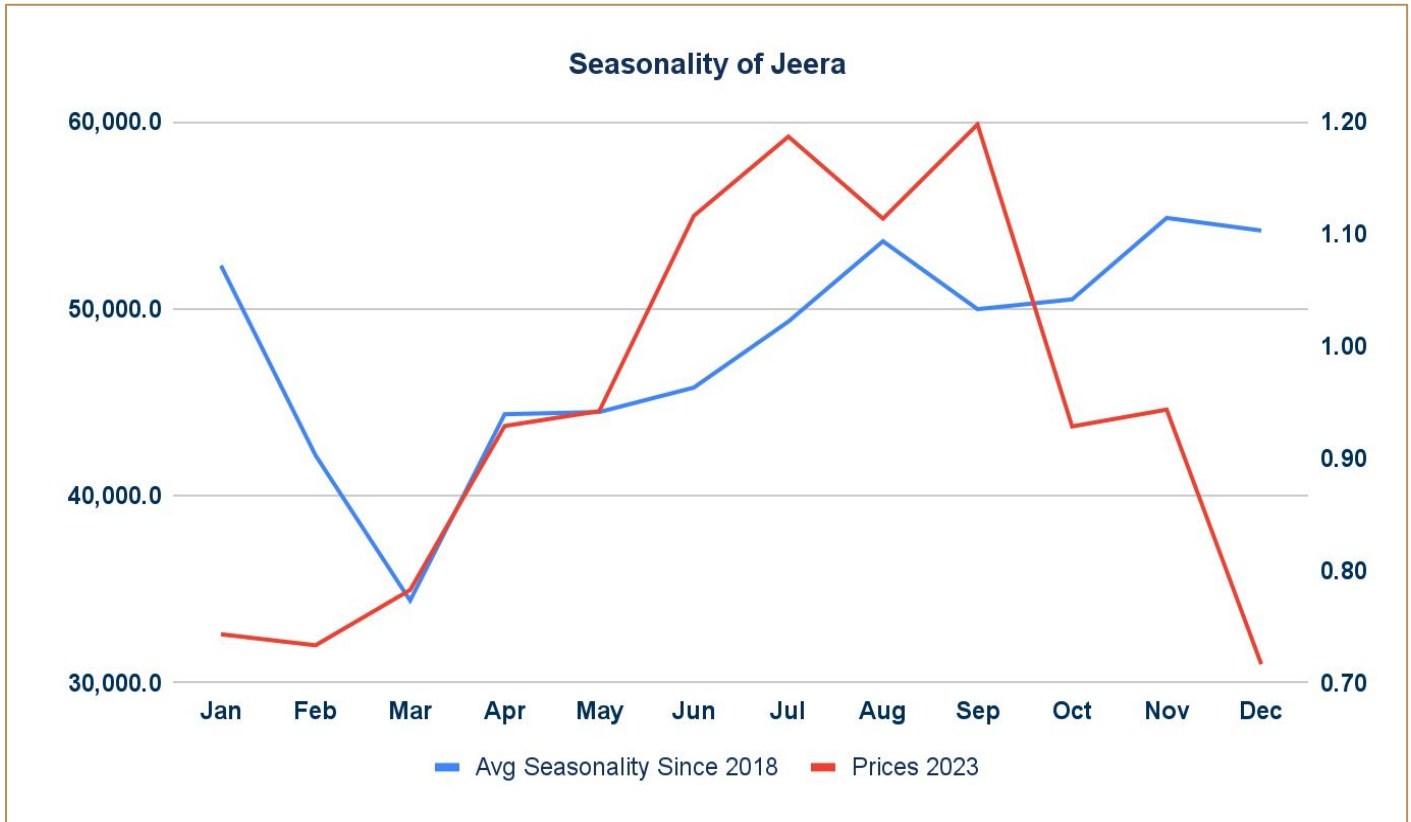

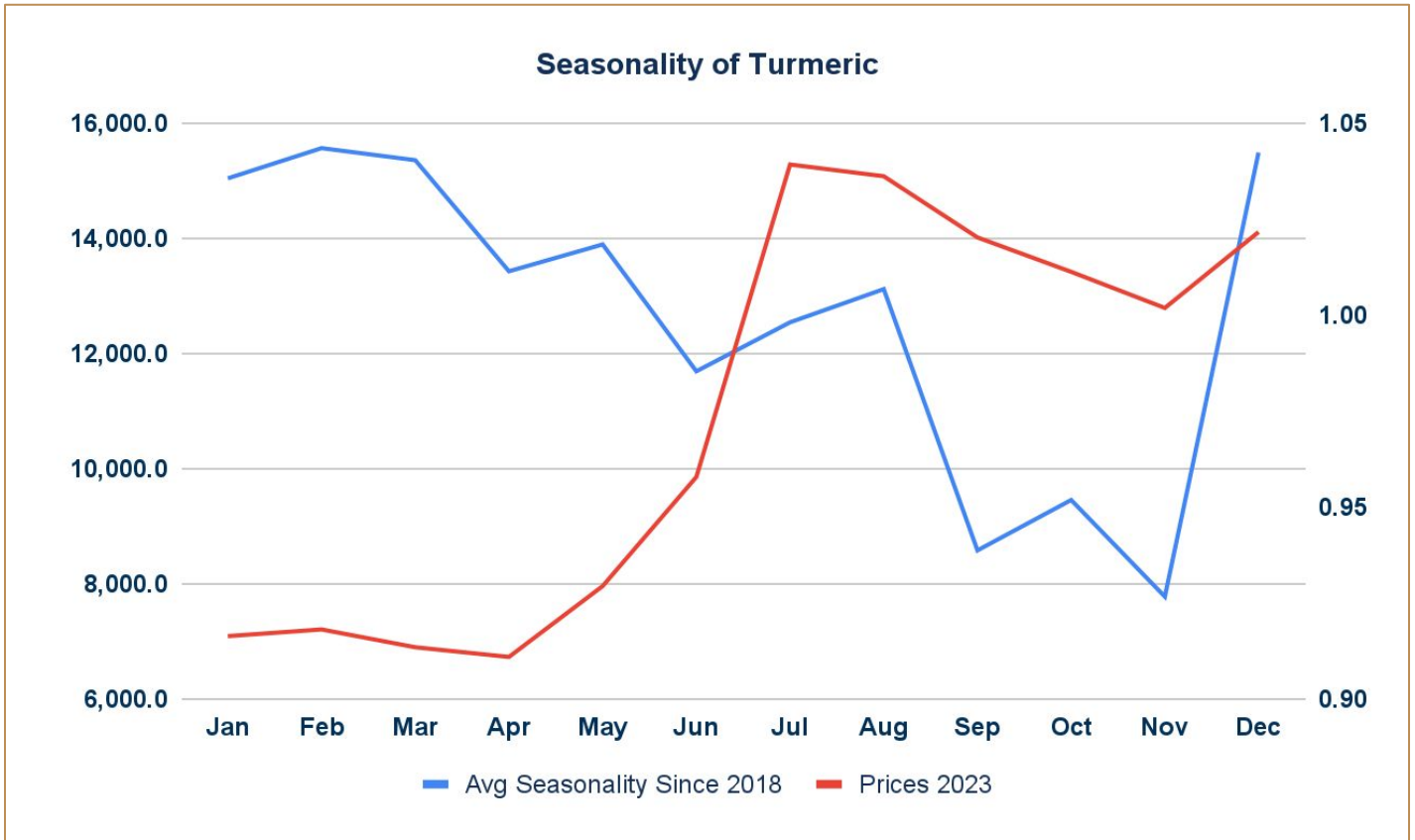
Turmeric exports during Apr-Oct 2023, rose by 2.63 percent at 1,02,162.94 tonnes as compared to Apr-Oct 2022.
